

Terms & Conditions for City Centre Businesses 2025 Christmas in Mandurah Window Competition

Information regarding Prizes and how to enter the Competition forms part of these Terms & Conditions. By submitting a competition registration, Entrants accept these Terms & Conditions.

- 1. The "Promoter" is City of Mandurah ABN 43 188 356 365, organising the Competition and referred to as the "City".
- 2. The Christmas in Mandurah Window Competition "Competition" is open to businesses physically located within the City Centre area of the City of Mandurah.
- 3. "City Centre" is defined as the area bounded by Hall Park (Western Foreshore) to the South; and the eastern and southern boundaries follow part of Pinjarra Road, Sutton Street, Eastern Foreshore, Boardwalk Precinct, Civic precinct, and Mandurah Ocean Marina.
- 4. The "Entrant" relates to the business who is entering the Competition via the survey/registration link.
- 5. An "Entry" means any entry in this Competition competing for the "Prize" as set out in the messaging of that Competition.
- 6. The "Winner" refers to the Entrant selected and allocated a Prize.
- 7. The Competition voting period commences 1 December 2025 and closes 31 December 2025, 11:59pm WST.

- 12. The Winners will be announced in January 2026, at the City of Mandurah Administration Building, 3 Peel Street, Mandurah WA 6210.
- 13. The City will make all reasonable attempts to contact the Winner from the draw date.
- 14. If the City has been unable to contact the Winner within a reasonable timeframe, the Prize will be forfeited and a new Winner will be drawn.

- 2. The Christmas in Mandurah Window Competition "Competition" is open to businesses physically located within the City Centre area of the City of Mandurah. The Competition is open to members of the general public who submit a valid vote during the voting period.
- 3. "City Centre" is defined as the area bounded by Hall Park (Western Foreshore) to the South; and the eastern and southern boundaries follow part of Pinjarra Road, Sutton Street, Eastern Foreshore, Boardwalk Precinct, Civic precinct, and Mandurah Ocean Marina.
- 4. The "Voter" relates to the person who is casting a vote via the survey/voting link.
- 5. A "Vote" means any submission in this Competition competing for the "Prize" as set out in the messaging of that Competition.
