### Conditions

Every permit is issued subject to the following conditions –

- Registrations for all dogs are to remain current at all times;
- Permit approval applies only to:
  - a. the dogs named above; and
  - b. the nominated property.
- City of Mandurah is to be advised in writing if any of the dogs are relocated or pass away;
- the dogs are not to cause a nuisance by barking or otherwise;
- the dogs must be effectively confined to the property and prevented from wandering;
- breeding of the dogs is not permitted;
- the dogs are to be maintained in good health and kept in humane, hygienic conditions;
- the dogs are not to be tethered at the property unless adequately supervised; and
- all the dogs must be microchipped, in accordance with the *Dog Act 1976*.

### This permission may be reviewed and/or revoked if –

- a. An offence is committed under the *Dog Act 1976* by any of the dogs or a person in charge of the dogs; or
- b. a substantiated complaint is received; or
- c. any of the conditions of this approval are breached.
