## ITEMS ACCEPTED FREE OF CHARGE

For cars, utility, van or trailer (residential customers only)
<ul style="list-style-type: none"><li>• All scrap metal, including fridges, washing machines and microwaves</li><li>• Cardboard</li><li>• Gas bottles (less than or equal to 9kg)</li><li>• Car batteries</li><li>• General packaging recyclables</li><li>• Household hazardous waste (maximum of 20 litres or 20 kgs per item)</li><li>• Engine oil (maximum of 20 litres)</li><li>• Compact fluorescent globes</li><li>• E-waste</li><li>• Paint</li></ul>

## VOUCHER ENTRY/USAGE

For cars, utility, van or trailer
<ul style="list-style-type: none"><li>• Waste vouchers are only issued to properties that pay the waste service charge</li><li>• Ratepayers of the City of Mandurah who pay for a household waste service are entitled to free entry upon presentation of a valid waste voucher</li><li>• Each voucher can be used to dispose of 1 m<sup>3</sup> of general or green waste from a car, utility, van or trailer.</li><li>• Up to 4 car tyres can be disposed of using a general waste voucher. Additional tyres will be charged as per gate fees</li><li>• Asbestos waste will be charged separately</li><li>• Each voucher is individually bar coded and contains specific information about the property. The City can track vouchers through the barcode and vouchers that are sold on social media will be voided</li><li>• A valid voucher must be presented to the gate attendant at the time of entry to gain free disposal.</li><li>• Vouchers are not transferable or redeemable for cash</li><li>• Vouchers are valid for one year only and expire on 31 August each year.</li></ul>
